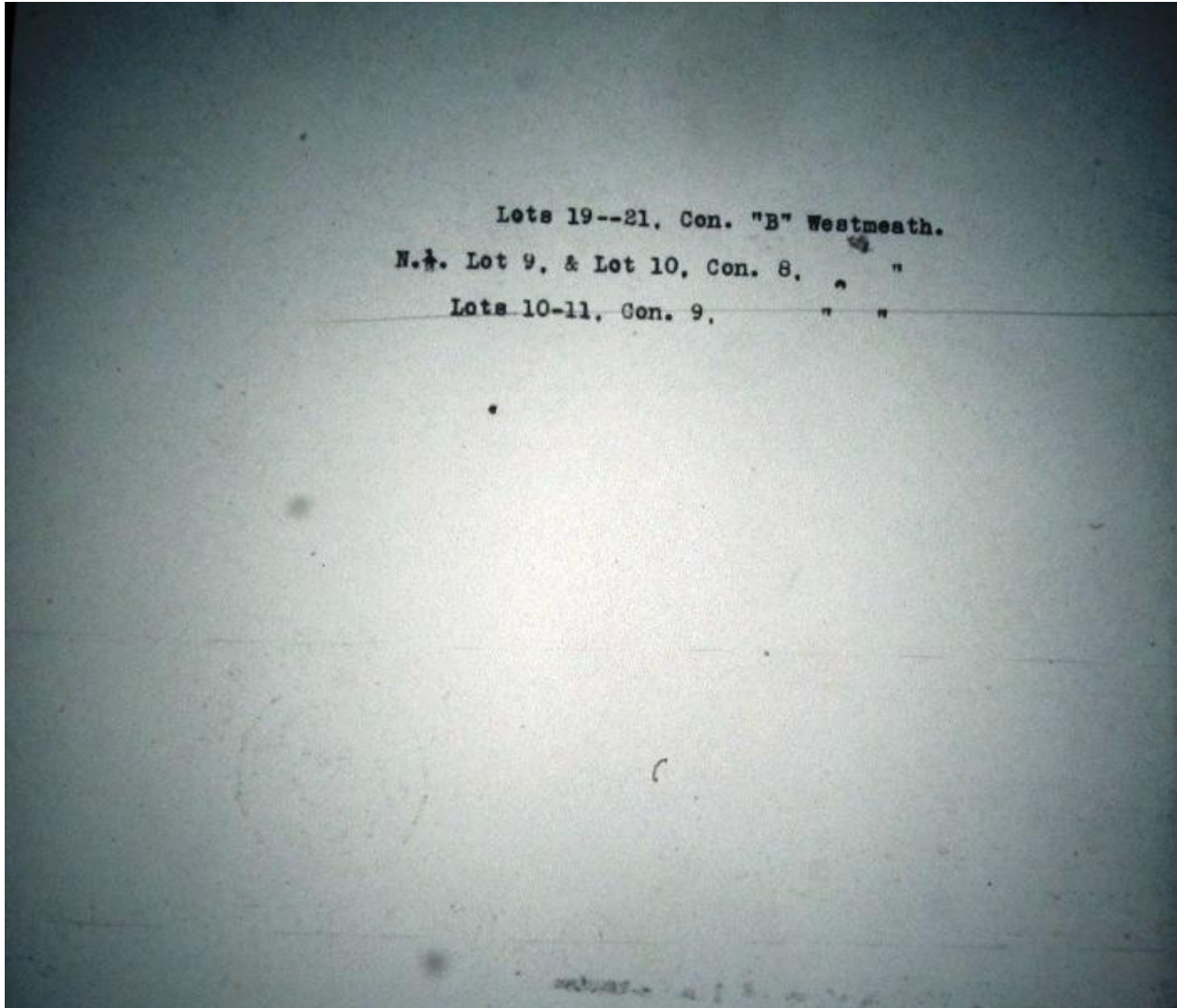

of Twenty-two years Service under the Order from the
Admiralty Office of the 3rd March 1832.

Early in June 1036 improvements commenced
upon the above grant. Fourteen Acres are now
under crop, six others chopped & soon to be cropped,
Twenty Acres.

Shanty of 1036 14 feet by 12 feet. Dwelling
house of last years erection 10 feet square.
A third erection now ready for roof is 15 feet square.
Resident settlers upon grant eleven in number.
I have to request you will issue through Mr.
MacKangin Agent for this District, or if absent to myself
direct, the Patent now due.
